

Terms & Conditions – Scream Time

1. General Safety

- 1.1 All visitors must remain on clearly marked paths and designated front-of-house areas within Scream Village at all times.
- 1.2 Children and vulnerable adults must be supervised by a responsible adult at all times.
- 1.3 Visitors must exercise caution throughout the event, which takes place outdoors in a country estate setting after dark during the autumn season.
- 1.4 Guests must not touch lighting, electrical equipment, props, set dressing, or any operational infrastructure.

2. Assumption of Risk

- 2.1 Attendance at Scream Time involves participation in an immersive horror experience that includes environmental hazards such as low lighting, uneven terrain, and outdoor conditions.
- 2.2 Certain areas may not be suitable for individuals with balance disorders or other medical conditions that may be affected by such environments.

3. Special Effects Warning

- 3.1 The event includes the use of special effects across all areas, including but not limited to:
 - Strobe lighting and flashing lights
 - Pulsating and rotating lighting effects
 - Haze and smoke effects
- 3.2 These effects are continuous and integral to the experience. Guests with photosensitive epilepsy or similar conditions attend at their own risk.

4. Live Actors and Interaction

- 4.1 The event includes live scare actors who may interact with guests as part of the experience.
- 4.2 Guests must not touch, grab, or physically engage with any performers under any circumstances.
- 4.3 Any inappropriate behaviour towards actors or staff may result in removal from the event.

5. Filming, Photography and Media Consent

- 5.1 By purchasing a ticket and entering the event, you acknowledge and agree that you may be filmed, photographed, or recorded by authorised representatives of the event.
- 5.2 Recording may take place via live cameras, fixed cameras, roaming cameras, or other recording equipment positioned throughout the site.
- 5.3 You grant J9 Events Ltd full permission to use your image, likeness, and voice captured during attendance for marketing, advertising, promotional, and social media purposes.
- 5.4 This includes use in digital and online media, social platforms, trailers, advertising campaigns, and other promotional materials worldwide, in perpetuity, and without compensation.
- 5.5 If you do not consent to such recording and use, you should not attend the event.

6. Compliance and Removal

6.1 Failure to comply with these Terms & Conditions or instructions from event staff may result in removal from the event without refund.

6.2 Any breach of site rules may be treated as trespass and dealt with accordingly.
